

California Workers Compensation information is important to all employed persons and every California injured worker. [Crimson Law Group](#), handling La Habra Workers Compensation claims, is well versed in the law. We want you to know that California Work Comp adjusters work for the insurance companies, not you. They are all about cost containment, and may not fully explain to you all of the rights and benefits to which you are entitled to under California Workers Comp laws. Some of the recoveries available are as follows:

- Medical Treatment
- **La Habra Temporary Disability**
- La Habra Permanent Disability
- Lump Sum Payments

California Workers Compensation insurance will pay for the medical treatment of an injury or illness if the injury occurred on the job, or in the course and scope of work. California Workman's Compensation insurance will also replace some of the worker's lost wages if the injury or illness caused the worker to lose some or all income after three days of temporary disability from a California work injury. Crimson Law Group, handling La Habra Workers Compensation claims, will look after your interests.

In California, employers are required to carry Workers' Compensation insurance, or qualify for self-insurance to cover such injuries. Determining your eligibility and compensation can give rise to complex issues which may lead to disputes, and that is when you will need an experienced California Workers' Compensation lawyer at Crimson Law Group advocating for you to make sure you receive fair payment and medical care for your injuries.

An injured worker in California is entitled to all reasonable medical care and treatment needed to cure or relieve a specific work-related injury or continuous trauma or repetitive stress or repetitive strain injury. Medical care covered by California Workers Compensation insurance claims include: medical, surgical and hospital services, dental services, crutches and orthopedic devices, hearing aids, chiropractic treatment, physical therapy, nursing care, and prescribed medications. California Workmen's Compensation cases cover a variety of work injuries ranging from temporary disability to total or partial permanent disability.

You may be entitled to a settlement for a partial permanent disability award if you have permanent work restrictions imposed because of your work injury or job related injuries. Medical

evidence will determine the extent of your temporary as well as permanent disabilities. The value of your claim depends, in large part, on the extent of permanent disability. Crimson Law Group, in doing **La Habra Workers Compensation claims**, will ensure that your claim is handled properly and in your best interest.

You should also be aware that if you were financially dependent on a deceased California injured worker, you may be entitled to death benefits from California Workmen's Compensation insurance. Death benefits may be available to any dependent household member of a deceased California injured worker, not only a spouse or natural child under California Workman's Compensation law.

California Workers Compensation laws can be very complex and confusing. Temporary and Permanent Disability benefits, medical benefits, injury settlements and death benefits are determined by California labor codes and laws specific to California.
